Donna North High School has been identified under the Public Education Grant (PEG) program as authorized under Texas Education Code, because the campus had fewer than 50% of its students passing English Language Arts (ELA) in 2014 and 2016.

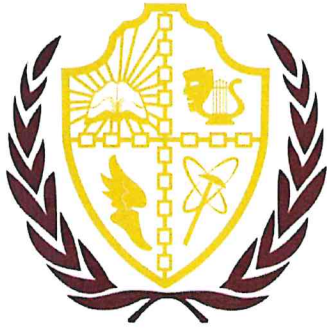
The Texas Legislature created the Public Education Grant (PEG) program in 1995. The PEG program permits parents whose children attend schools on the PEG list to request that their children transfer to schools in other districts or inter-district for the following school year. Included on the PEG list are campuses with passing rates on STAAR that are less than or equal to 50% in any two of the preceding three years: 2014, 2015 or 2016 or the school was rated Improvement Required in 2014, or 2015.

The staff at DNHS has been working diligently to ensure student academic performance in ELA. Targeted tutorials are being provided on a regular basis in ELA.

The Public Education Grant (PEG) program allows parents whose children attend schools on the PEG list the right to request a transfer to another school within the district or to another district for the 2017-2018 school year. Donna I.S.D. parents of students wanting transfers within the district should submit their request in writing to the principal of the school your child is currently attending. Donna I.S.D.'s regular transfer request procedures must also be followed. Parents of students wanting to transfer outside of the district should address their requests in writing to the Superintendent of the school district of their choice. According to statute, school districts are entitled to accept or reject transfer requests. Transportation will not be provided by Donna I.S.D., should your transfer request be accepted by another district. Queridos Padres,

Donna North High School ha sido identificada bajo el Programa de Subsidio de Educación Pública (PEG) como autorizada bajo el Código de Educación de Texas, porque nuestro plantel tiene menos de 50% de sus estudiantes pasando el examen de lectura/escritura en 2014 y 2016.

La Legislatura de Texas creó el Programa de Subsidio de Educación Pública (PEG) en 1995. El programa PEG permite que padres cuyos hijos asisten a escuelas que se encuentran en la lista de PEG puedan requerir que sus hijos sean transferidos a escuelas en otro distrito o dentro del distrito el siguiente año escolar. Incluidas en la lista de PEG están escuelas que tienen tasa de calificación aprobada en STAAR que tienen menos que o igual que un 50% en dos de los tres años anteriores: 2014, 2015, 2016 o que la escuela haya sido identificada con mejoramiento requerido en 2014 o 2015.

El personal de la escuela DNHS ha estado trabajando diligentemente para asegurar el éxito académico en lectura/escritura. Tutoría enfocada ha sido proveída regularmente en lectura/escritura.

El Programa de Subsidio de Educación Pública (PEG) permite a los padres cuyos hijos asisten a escuelas PEG el derecho de requerir un cambio dentro del distrito o a otro distrito para el año escolar 2017-2018. Los padres de estudiantes del Distrito Independiente de Donna que deseen transferencias dentro del Distrito deberán solicitarlo por escrito al director/a de la escuela donde asiste su hijo/a. Todos los procedimientos de solicitud de transferencia del Distrito Independiente de Donna deberán seguirse. Padres de estudiantes que deseen una transferencia fuera del distrito deberán solicitarlo por escrito al superintendente del distrito escolar de su preferencia. De acuerdo al estatuto los distritos escolares tienen derecho de aceptar o rechazar la solicitud de transferencia. Si su solicitud de transferencia es aceptada por otro distrito, el distrito escolar de Donna no proveerá la transportación.
